

AIXR Community Standards

Introduction

These Community Guidelines and Policy ("Community Guidelines") govern the conduct and interactions of users ("Users" or "you") on the AIXR platform, operated by AIXR LTD, (company number 14982097) ("AIXR", "we", "us", or "our"). By accessing or using our platform and services, you agree to abide by these Guidelines, as well as our Terms of Service and any other applicable policies.

Failure to comply with these Guidelines may result in actions against your account, including but not limited to warnings, suspension, or termination of your access to the platform and services, without refund. AIXR reserves the right to take legal action against users who engage in activities that violate these Guidelines, applicable laws, or regulations.

Professional Conduct

As a business-oriented platform, AIXR expects all users to maintain a professional demeanour and engage in respectful, constructive, and courteous interactions with other users. The following behaviours are strictly prohibited:

- a. Hate speech, harassment, bullying, or discrimination based on race, ethnicity, religion, gender, sexual orientation, disability, or any other protected characteristic.
- b. Sharing or promoting adult, explicit, or offensive content.
- c. Creating or using fake AI accounts or misrepresenting your identity or affiliation.
- d. Engaging in any form of scam, fraud, or dishonest business practices, including but not limited to selling or promoting NFTs or other items that may be deemed fraudulent or untrustworthy.

Our guidelines stipulate that you:

1. Be Respectful

Treat all users with respect, and be mindful of different cultural backgrounds, beliefs, and perspectives. Discrimination, harassment, or any form of hate speech based on race, ethnicity, gender, religion, sexual orientation, age, disability, or any other protected characteristic will not be tolerated.

2. Maintain Professionalism

Keep conversations and interactions focused on industry-related topics and maintain a professional tone. Refrain from using offensive language, engaging in personal attacks, or sharing inappropriate content. The platform is meant for business purposes, and users should behave accordingly.

3. Protect Privacy

Do not share your own or other users' personal information, such as email addresses, phone numbers, or home addresses, without explicit consent. Additionally, respect the privacy of others by not recording, screenshotting, or sharing private conversations without permission.

4. Uphold Intellectual Property Rights

Only share content that you own or have the right to use. Do not upload, post, or share copyrighted material, trademarks, or other intellectual property without proper authorization.

5. No Fraudulent Activities and Scams

Do not engage in any fraudulent activities, including attempting to sell fake NFTs, promoting Ponzi schemes, or other scams. Be transparent and honest in your dealings with other users on the platform.

6. No Fake Accounts or Impersonation

Do not create fake AI accounts or impersonate other individuals or entities, including AIXR staff, instructors, or other users. Always be honest about your identity and affiliations.

7. Adhere to Legal Requirements

Ensure that your actions on the platform comply with all applicable laws and regulations, including those related to data protection, privacy, and intellectual property.

9. Limited Self-Promotion

While users are allowed to promote their professional services or products, direct sales or solicitation through the platform is prohibited. Users should focus on contributing valuable insights and knowledge to the community instead.

Advisor Status Requirements

Users with Advisor Status must meet specific eligibility criteria, including but not limited to having a minimum of 2 years of industry experience and complying with the published guidelines for Advisors. AIXR reserves the right to review, verify, and revoke Advisor Status for users who fail to meet these requirements or violate these Guidelines.

No Unauthorised Sales or Solicitation

Users may promote themselves and their professional services on the platform but are strictly prohibited from selling products, services, or engaging in any form of solicitation through the platform without AIXR's prior written consent. Users must not solicit AIXR staff or attempt to conduct business transactions with AIXR staff without authorization.

Reporting and Enforcement

If you encounter any violations of these Guidelines or suspect any inappropriate or illegal activity on the platform, please report it to AIXR immediately at support@aixr.org. AIXR will investigate all reports and take appropriate action, including issuing warnings, suspending or terminating accounts, or involving law enforcement authorities if necessary.

Updates and Amendments

AIXR reserves the right to update, amend, or modify these Guidelines at any time and at its sole discretion to address new issues, clarify existing policies, or improve the platform's user experience. We will notify users of any significant changes to the Guidelines through the platform or other appropriate communication channels. Your continued access or use of the platform and services after the effective date of the changes constitutes your acceptance of the updated Guidelines. If you do not agree to the changes, you must stop accessing or using the platform and services.

Legal Compliance and Liability

By agreeing to these Guidelines, you warrant that you will comply with all applicable laws, regulations, and industry standards while using the AIXR platform and services. You also agree to indemnify, defend, and hold harmless AIXR, its affiliates, and their respective officers, directors, employees, and agents from and against any claims, liabilities, damages, losses, or expenses, including reasonable attorney's fees, arising out of or in any way connected with your access to, use of, or alleged use of the platform and services, your violation of these Guidelines or any other applicable policies, or your infringement of any intellectual property or other rights of any third party.

These Community Guidelines and Policy are legally binding and form part of the agreement between you and AIXR. Any violation of these Guidelines may result in legal consequences, including but not limited to liability for any damages, losses, or expenses incurred by AIXR or other users as a result of your actions.

Dispute Resolution

Any disputes or claims arising out of or in connection with these Community Guidelines and Policy shall be resolved in accordance with the dispute resolution provisions set forth in the AIXR Terms of Service. Both parties agree to submit to the exclusive jurisdiction of the courts of England and Wales to resolve any disputes or claims arising out of or in connection with these Guidelines.

Severability

If any provision of these Guidelines is found by a court of competent jurisdiction to be invalid, illegal, or unenforceable, such provision shall be modified to the minimum extent necessary to make it valid, legal, and enforceable, and the remaining provisions of these Guidelines shall remain in full force and effect.

No Waiver

AIXR's failure to enforce any right or provision of these Guidelines shall not constitute a waiver of such right or provision unless acknowledged and agreed to by AIXR in writing.

Entire Agreement

These Community Guidelines and Policy, along with the AIXR Terms of Service and any other applicable policies, constitute the entire agreement between you and AIXR with respect to your access and use of the platform and services, and supersede all prior or contemporaneous understandings, agreements, negotiations, representations, and warranties, both written and oral, with respect to the subject matter hereof.
